

## Your Welcome Adoption Packet

**Congrats on the new addition to your home.** I would like *you* to take *time* to review your adoption packet.

Remember that at anytime if you have questions, concerns or comments please do not hesitate to contact us. You will find our business card with our contact information inside the folder or at [www.adoptaboston.com](http://www.adoptaboston.com).

Your **Trial Period is for TWO WEEKS**. We ask that you keep us informed on how your new dog is doing during this period of time. We ask that you **update us** via phone or email:

1. within 48 hours of getting your new dog
  2. at one week of having your new dog
  3. at two weeks from having your new dog at which time we finalize the adoption
- \*A MABTR volunteer will also be emailing you at the one and two week touch point*

**The adoption CONTRACT and FEE will be collected prior or at the time of adoption.**

-if the adoption is conducted by the foster parent these two items will be collected at the time of transition.

-if your new dog is being transported please read the following: (you will not give anything to the driver)

\* The **contract** has or will be emailed to you as a PDF file. Please print, complete/sign and scan back. If you do not have the ability to scan you can mail the contract to 14826 Spaulding, Omaha, NE 68116.

\* The **adoption fee** can be paid via Credit Card or Check.

Enter Amount = adoption fee + \$25 transport, if applicable

Enter notes stating “adopting (dog’s name)”

You should find in the folder:

- Our **business card**. Our mailing address is located on the back of the card. We are available 24/7.
- **Boston Note** Page. This consists of tips and facts about Bostons that we felt were important for you to know and could find beneficial.
- **Vet Papers**
  - You should have a copy of the RABIES vaccination certificate and proof of distemper shot which you will need to register your new dog with your state.
    - We recommend you not register him/her until you finalize your adoption.
  - We strongly recommend that you make COPIES of the vet papers for your vet and you maintain copies in your folder. These are the originals.
- **Adoption Contract**
  - Your copy of the adoption contract is your legal document of ownership of this dog.
  - The adoption fee *is* set by the age of your dog *and* is also stated on the contract. This includes the registration cost for the microchip. It does NOT however include the transport fee if applicable, the purchase of a sweater and/or crate should *you want to* purchase one from MABTR.
- **Microchip Number**
  - The microchip inserted in your dog is a **lifetime membership**. Any notifications that your membership has expired is false
  - Your dog’s microchip number should be stated on the front of the folder and on the contract.
  - The microchip tag, if available, should be on either the collar or harness that you will be leaving on your dog at all times.
    - If you do not have a tag please email [luckypawpals@aol.com](mailto:luckypawpals@aol.com) requesting one.
  - The microchip is registered in MABTR’s name. The new owners will be listed as secondary UPON request.
  - If you move please send MABTR your new contact information should your dog go missing.
